She began opening up very deeply about her past, and we were able to find her some counselling, pray together and start to do some discipleship with her and her husband.

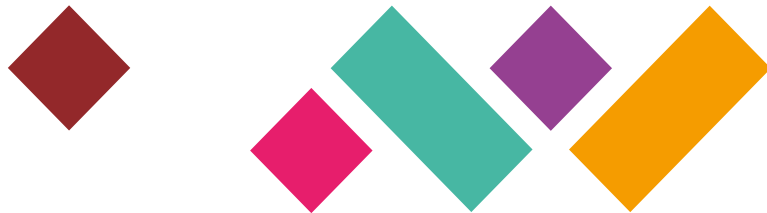
